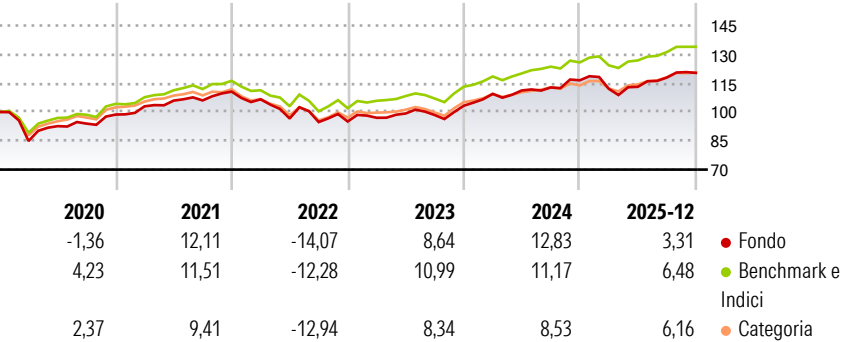

The investment objective of the Fund is to achieve long-term capital appreciation. The Fund seeks to achieve its investment objective by investing its Net Asset Value in units of a diversified portfolio of Underlying Funds. The Fund: (1) may invest up to 65% of its Net Asset Value in units of Underlying Funds that provide exposure to equities issued by companies incorporated anywhere in the world; (2) may invest up to 50% of its Net Asset Value in units of Underlying Funds which provide an exposure to government or corporate debt securities of Investment Grade and/or non-Investment Grade with a fixed or floating rate, provided that exposure to non-Investment Grade will be limited to maximum 30% of the Net Asset Value of the Fund; (3) may...

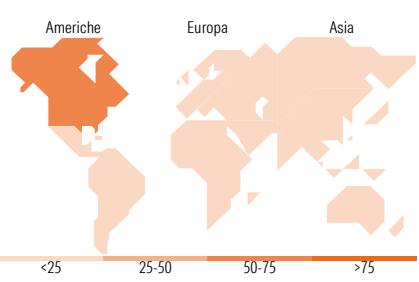
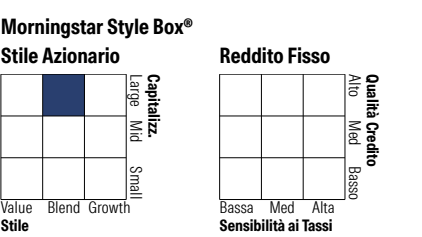
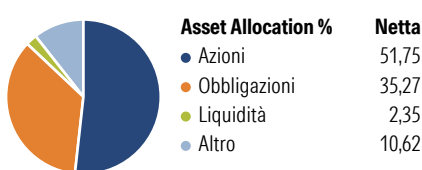
